ACIPC is a company, limited by guarantee and incorporated under the Corporations Act. It is a not-for-profit association that is also a registered charity with the Australian Charities and Not-for-Profits Commission

(ACNC) and is endorsed as a deductible gift recipient (DGR) from 12 January 2012.

The importance of infection prevention and control in all healthcare facilities cannot be overstated. In an era when antibiotic resistance is increasing, antimicrobial stewardship becomes the responsibility of all infection prevention and control professionals.

**Infectious Diseases Physician and Clinical Microbiologist at ACT Pathology and Canberra Hospital**


**Professor in the Medical School of the Australian National University**

# President's report

**It is my great pleasure to provide you with the ACIPC Presidents report for 2020. From the outset, I would like to express my sincere gratitude to all ACIPC members for their efforts in what has truly been an extraordinary year. I congratulate you all for responding to this pandemic. Your dedication and tireless persistence has resulted in a lull of cases in Australia, even though we must acknowledge it may be just the trough before the next wave.**

I am sure you will agree with me when I say that as somebody who works in infection prevention and control, COVID-19 entered our country accompanied by a bright and rather large spotlight on infection prevention. There is a sense of shallow irony that it has taken a devastating pandemic to highlight the important issues we have been aware of for decades. But like many things, occasionally bad things need to happen before good things can.

In February this year, not long after the first cases of COVID-19 were identified in Australia, the ACIPC Board met face to face over two days for orientation of new members and strategic planning. It was a proud moment to see the new board assembled around the table. At that time, we had much discussion about ensuring the College was serving its members well, and we established 3 major Strategic Priorities for 2020-21.

- Strengthen our profile as the peak body for IPC through effective communication and relationships with members, industry, and partners
- Establish an agile and sustainable structure that will optimise College resources to meet member and stakeholder needs
- Strengthen the profile of infection prevention and control as a profession

Whilst the year didn't quite pan out as we had thought in February, the Colleges' profile has certainly strengthened, the importance of infection prevention has never been so prominent, and our agility has meant we have been able to respond to the increased demands, particularly in education.

I would now like to highlight some of the Colleges achievements during this challenging year.

In March 2020, the College strengthened engagement with Conference Design and Ben Thiessen, who has had an association with the college for many years, took up the role of Executive Manager. We also tightened the relationship between our Education Officer Jackie Miley and our Secretariat. These new arrangements reduced the administrative burden and cost on the College and provided a more robust infrastructure.

Our Education Manager, Jackie Miley has overseen a significant increase in student numbers across our education portfolio. During the year, our Foundations students increased from approximately 100 in 2019 to over 440 in 2020 already. We also saw the introduction of two new educational offerings in infection prevention in aged care, an online short course as well as a masterclass.

The impact of COVID-19 in aged care has highlighted many gaps, not the least, infection control expertise in these areas. Through many representations with the Commonwealth Department of Health, our Foundations course has been recognised as a core education requirement of the IPC clinical lead in aged care facilities across Australia, as recommended by the Royal Commission. It was also noted the

Commission recommended that aged care facilities appoint credentialled experts in infection control. To that end, we are investing further to increase our educational resources to meet the needs of healthcare workers in these areas, and we are establishing a new Aged Care Committee to assist and advise on these issues. We currently have 64 credentialled members across all three levels, Primary, Advanced and Expert, and we anticipate a significant increase in these numbers too.

As with most events in 2020, the College took the difficult decision to cancel our annual Conference. As many members would agree the Conference is a highlight of our IPC calendar and an excellent chance to come together with colleagues and friends. A star-studded line up of international speakers was planned, as well as several new conference innovations which we now hope to display in Adelaide next year. On behalf of the college I would like to thank the work of the Conference Scientific Committee chaired by Brett Mitchell who had assembled an excellent program.

In lieu of the Conference, the College has developed the ACIPC Conference Community for members and our stakeholders. I would particularly like to acknowledge the support of our corporate partners in 2020, and I strongly encourage all members to participate in the Conference Community events. The willingness of our industry partners to support the College and our educational activities can not be underestimated. I especially thank the following: GAMA HealthCare, 3M, SC Johnson, Tristel, Ecolab, ITL Biomedial, Reynard Perrigo and One Passport

The College appointed 4 more Fellows this year; Dr Stephane Bouchoucha, Professor Marilyn Cruickshank, Ms Sandra Roodt and Professor Ramon Shaban. Fellowship of the College recognises significant professional achievement and contribution to the ACIPC and the IPC profession. Congratulations to our newest Fellows.

Infexion Connexion continues to be well subscribed and utilised this year. Thank you to Michael Wishart for moderating the members forum which, with the growth in membership has in turn experienced an increase in posts. Members constantly tell us how much they value this information sharing platform.

Our journal, Infection Disease and Health continues to go from strength to strength. Submissions to the journal have increased year on year for the past 5 years, with a significant increase this year. During this time, the journal has continued to provide a speedy editorial process, compared to like journals. This is in large part to the reviewers who support the journal.

Thank you to everyone who has undertaken a peer review this year. Special thank you for those who assisted with a rapid review panel for COVID-19. The ranking for our journal or cite score is also rapidly increase and we expect the journal to be in the top quartile of journals within the next 12 months. This brings with this recognition to the College and its members. I would like to congratulate the Editor in Chief, and Senior Editors Stephanie Dancer and Ramon Shaban for their excellent work.

The Colleges three main streams of income are membership, education, and the annual conference. Clearly, the decision to cancel the conference was not taken lightly given its importance to our income stream. However, it is pleasing to note that the College has finished the current financial year in a very strong position.

We have recorded an audited surplus of \$67,000. The surplus can largely be attributed to a growth in our education offerings in response to the needs of members and the wider IPC community. Our membership has also been steadily increasing from last year, from 1142 in 2019 to 1714 in 2020.

Whilst I do not wish to highlight this, I would like to note that given the uncertainty of our income with the cancellation of the conference, I invited all Board Directors (except for our Consumer Representative and Special Advisor) to consider suspending their fees in 2020. All Directors agreed, and I thank them for that.

With all attention on COVID-19, naturally we have of course seen a huge demand for the time and expertise of our elected officers and members of ACIPC. In many high-level representations, and committees the College participated in many such representations and collaborations, some of which are listed in this report. To give members an indication of how the College has been officially represented, we have included some of the committees, organisations and media interviews.

Throughout the calendar year the College has spoken in support on a number of issues, often in partnership with other affiliated organisations. Most recently the College has expressed support for the Royal Commission into Aged Care Quality's call for more

expertise in aged care, and for a national centre for the management of this and future pandemic threats.

In conclusion, as President, I wish to also express my sincere gratitude to the Board Directors, Jackie Miley, Sara Kirby, Andrew Watts and Ben Thiessen and the Conference Design team for their work and support this year. Their outstanding efforts all year has afforded me the opportunity to present a very positive and strong outlook for the future of the College.

Again, I am thankful for our members work. Many of us, if not all, had to relinquish our "normal" work in order to respond to the urgent demands of COVID-19 which have consumed us every day, every week, every month, all year. And its not just our work life, many of us have been affected personally in different ways, and the various degrees of lockdown we have experienced across the country has indeed been very challenging.

Nevertheless, it is with much optimism and hope that I look forward to 2021, and I will cautiously suggest I will see you all in Adelaide next November.

## Associate Professor Philip Russo CICP-E, FACIPC

### President

Phil has worked in infection prevention and control for over 25 years in a number of different positions including: several roles in infection prevention in major Victorian hospitals, inaugural Operational Director of the VICNISS Coordinating Centre and National Manager of Hand Hygiene Australia. Phil has a Masters in Clinical Epidemiology and completed his PhD on HAI Surveillance in 2016. Phil was the Chair of the National Consultative Steering Committee, which outlined the roadmap for the establishment of ACIPC, and has been a board member of the college since 2014, previously chairing the research committee. He is also a member of the HAI Advisory Committee for the Australian Safety and Quality in Health Care Commission, and the National Health and Medical Research Council Infection Control Guidelines Advisory Committee. His current role is Director, Cabrini Monash University Department of Nursing Research.

Phil strongly supports national initiatives in healthcare prevention that are fostered by the college and is proud of the college's achievements in representing its members at both national and international forums since it commenced. #### **Immediate Past President**

Professor Marilyn Cruickshank is a registered nurse and Professor of Nursing Research at the University of Technology Sydney. In this role, Marilyn provides leadership for nursing research within the Sydney Children's Hospitals Network. Prior to this, for a 10-year period, Marilyn was Director of the national HAI program at the Australian Commission on Safety and Quality in Healthcare where she led work on national HAI surveillance, the national hand hygiene program, antimicrobial stewardship, national infection control guidelines, and Standard 3 of the National Safety and Quality Health Service Standards.

Marilyn developed a keen interest in infection prevention and control as a clinical nurse consultant for paediatric HIV, developing guidelines and policies for maternal transmission and children with HIV in hospitals and the community. Her PhD topic included the epidemiology of paediatric HIV in Australia. Marilyn is also a member of the Australian Scientific and Technical Advisory Group (ASTAG), and former chair of the AMR Standing Committee. Marilyn has co-edited a number of publications on national AMS and HAI surveillance and has represented Australia at international meetings, such as APEC and the Western Pacific Regional Office of the World Health Organisation.

Marilyn was appointed as professor at School of Nursing and Midwifery, Griffith University in 2015.

### **Dr Stéphane Bouchoucha** **CICP-A**

#### **Director & Chair Education Committee**

Stéphane Bouchoucha is a senior lecturer and researcher at Deakin University. With over 20 years' experience as a registered nurse and an academic, Stéphane has worked in a variety of clinical (critical care, Infection Prevention and, Leadership and management) and community settings. Stéphane's involvement in Infection Prevention and Control dates from the late 1990s when he was a volunteer with AIDES (the main French NGO dedicated to HIV). He subsequently led the French involvement into Eurosupport 1, a Europe-wide study investigating HIV/AIDS patient access to care in European countries.

Stéphane has developed a program of research in infection prevention and control informed by his Master of Science (Public Health) and PhD where he investigated the psychosocial factors affecting adherence to Standard Precautions, and he developed and validated a scale: the Factors Influencing Adherence to Standard Precautions Scale (FIASPS).

As an early career researcher, in 2016, Stéphane was successful in receiving two early career grants, one of which was from the ACIPC, to consolidate infection prevention and control work.



### **Sally Havers** **CICP-E, FACIPC**

Sally is a committed infection control professional of ten years, with a passion for improving and ensuring safe patient care.

Sally's experience includes management and completion of large scale, multi-centre research projects (including ethical clearance and protocol development) as well as successfully project managing the development and roll out of a large national infection prevention program.

# From the Executive Manager

Since taking on the Executive Manager role in April we have faced a number of challenges and opportunities. As the year progressed, we saw a surge in demand for our education courses, particularly the Foundations of Infection Prevention and Control and the Online Short Course in IPC in Aged Care Settings. # Company & organisational structure

**ACIPC is a company limited by guarantee and incorporated under the Corporations Act 2001 (Corporations Act). This means that our board of directors have all of the same legal and financial duties and responsibilities as directors of large companies and institutions.**

**ACIPC is a not-for-profit organisation, which means we do not pay dividends to shareholders. While it is commonly believed that holding not-for-profit status means an organisation should not generate a surplus, financial sustainability is a cornerstone of any successful organisation, so it is in fact essential that ACIPC remains profitable, to ensure that we remain solvent.**

**The College is a registered charity reporting to the Australian Charities and Not-for-Profits Commission (ACNC) and is registered as a deductible gift recipient (DGR). DGR status means that any donations made to ACIPC receive a tax receipt for use as a tax deduction by the donor.**

**Lastly, and perhaps most importantly, the college is a member association; meaning it is your association – run by members, for members.**


College funds are raised through:

- individual and corporate membership payments.


Funding is not received from any government sources. It is mandatory that all college funds are used for the benefit of members and for the ongoing management of the college.





# ACIPC Education Manager's report

Physical ACIPC events were ceased in mid-March 2020 in line with chief health officer advice and travel restrictions. Prior to that time, two events were held; a trades masterclass in Melbourne in February and IPC in disability care in Sydney in March. Once it was clear that restrictions would be ongoing, a decision was made to transition the successful aged care face-to-face workshops to an online delivery format, to ensure continuing IPC education and support during this important time.

ACIPC offered a significantly increased volume of courses over the last 12 months.

For this period, the total number of individuals educated exceeded 990 participants.

The number of courses delivered and participants - both completed and currently in progress - since November 2019, is summarised in the following tables.

Course student evaluations are overwhelmingly positive. Flexibility in the delivery mode, feedback from the tutor, information being practical, quality of the resources delivered, balance of video presentations, reading, and activities were prevalent positive observations.

Courses are continually updated with recent evidence and expert opinion, guidance, and resources.

In April ACIPC ran a series of 4 co-badged webinars with GAMA Healthcare to assist health care colleagues during the COVID-19 pandemic.

A COVID-19 Q&A for healthcare workers was run by the college as part of the launch of the online *ACIPC Conference Community* in October.

### Upcoming Events

Upcoming events will be an **Aged Care Masterclass** with 13 presentations on high level issues on aged care IPC, delivered by several learned, experienced practitioners and academics. This will be offered on our Moodle platform in October 2020.

We are fortunate to have also recorded three webinars '**Tales from the COVID-19 frontline with Ann Whitfield**' which will be launched as part of part of Conference Community.

### AS/NZS 4187:2014 Online Symposium

ACIPC planned to build on and expand the very popular pre-conference workshop on AS/NZS 4198:2014 held just prior to the 2019 conference in Perth where it attracted a capacity crowd of 232 attendees.

Presenters were secured and an expanded program was organised and agreed upon before travel and public event restrictions came into force across Australia. It was then proposed that the event be translated onto an online symposium, but this was placed on hold due to COVID-19 related activities taking precedence. The symposium remains on hold, awaiting the opportunity to record the presentations and launch the event.

### Technology

**Turnitin** – in use for a year now, has improved the academic integrity of the work submitted in assessments. Students reported an enhanced understanding of the academic writing process.

ACIPC has purchased licenses for: **Camtasia** (video editing program) and **Doodly** (short animated video tool).

These programs assist with recordings, shorten recording time, and improve 'rich learning' in our courses.

**Poll Everywhere** has also been made available to facilitate and assessment of knowledge gain, opinion, insight, and satisfaction with face to face events.

Amongst other learning activities, ACIPC courses feature discussion forums for each topic, and students are active in demonstrating their knowledge, sharing experiences, perspectives, insights, and the odd frustration too!

I enjoy reading these knowledgeable, well supported, informative, heartening posts from students in all areas of healthcare.

There is such a lot of good IPC work going on out there. 'Rich learning' occurs as a result of sharing problems, issues, perspectives, and solutions based on the best available scientific evidence and supported by guidelines, in a safe and confidential learning environment.

Students report how much they like these moderated discussion forums and miss them after course!

The courses also form a support network for ACIPC students, who often remain in contact with each long after the course has finished.


### Achievements:

- Establishment of a rapid review panel for COVID-19 articles, during the first 6 months of the pandemic. This allows fast publication of suitable COVID-19 articles. A special thanks for all those involved in the rapid review panel.
- Increasing number of submissions, up approximately 150% compared to last year.
- Discussion and finalisation of a new Publishing contract.
- Increasing rejection rate, >90%.
- Increase downloads of publications:  
24,000 in 2017 increasing to 112,000 in 2019. Downloads for 2020 are set to exceed 2019.
- Increasing citations of journal and increasing metrics in all these areas:  
Year (Year to 7th September) the cite score for IDH is 2.1, up from 1.6 in 2019 and 1.3 in 2018.
- Fast time from submission to publication, compared to other journals.

### Opportunities:

- Peer review, member can get involved in peer-reviewing articles. This is a great opportunity to hear about emerging research first, as well as develop skills.

# Global outbreak alert & response network report

## Achievements:

ACIPC is a longstanding member of the Global Outbreak Alert and Response Network, a WHO network of over 250 technical institutions and networks that respond to acute public health events with the deployment of staff and resources to affected countries.

ACIPC members deploy generally as IPC experts, however roles can include specialist epidemiology, microbiology, communications, or laboratory staff, amongst others with a view to providing comprehensive teams to reduce the impact of international emergencies.

In 2020 ACIPC responded to nine requests for assistance from the GOARN team:

- 6 x COVID-19 – Philippines, Papua New Guinea, Timor Leste, Indonesia, Sao Tome, Principe
- 1 x Ebola Virus Disease – Democratic Republic of Congo
- 1 x Measles – Pacific Island Countries
- 1 x Refugee Camp Fire Emergency Response – Greece

ACIPC considered the requests and five applications for COVID response teams were submitted.

To date two of these applications resulted in offers of deployment however deployment did not occur due to changes in circumstances occurring prior to receiving the offers.

ACIPC and GOARN acknowledge the difficulty faced by IPC staff in trying to be released from their substantive duties during an active pandemic. Requests for Assistance remain open as per GOARN ongoing operations (figure 1 & 2).

ACIPC nominated members for training opportunities with GOARN in 2020. With international travel difficult, these training programmes were being conducted virtually allowing greater access.

ACIPC nominated three members for the GOARN Outbreak Response Leadership Training - Virtual “Sense-making” Workshops with all three nominations being successful.

These workshops are ongoing at the time of this report. One member was nominated for GOARN ArcGIS Foundational Training and was successful.

It has been a busy year for GOARN with multiple teams active for extended periods globally. There are currently seven ongoing emergency operations within GOARN (fig 1 & 2).

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2020

This financial report covers Australasian College for Infection Prevention and Control Ltd as an individual entity.

### 1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Preparation**

The financial report is a general purpose financial report that has been prepared in accordance with Australian Accounting Standards (including Australian Accounting Interpretations) of the Australian Accounting Standards Board and the Corporations Act 2001.

At each reporting date, the company assesses whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether an impairment has arisen. Impairment losses are recognised in the income statement.
