- ✓ This situation is however slowly changing (18% of providers now accept pets)
- ✓ Lifeview's experience of having pets move into care overcoming objections, changing the narrative and improving resident wellbeing

Meet Paul & Bonny

- ✓ Originally came into care mid 2022
- ✓ Eventually left against all advice
- ✓ Moved back late 2022
- Confided could not live without Bonny and this was causing him to be unsettled and depressed
- ✓ Bonny moved in early February

Why Pets?

- ✓ Eden philosophy
- ✓ We are pet lovers
- Understand the bond between pets and people
- Need to offer what the market wants
- ✓ We have seen the benefits





What is truly Pet Friendly?

- Residents can have their own pets live with them – dogs, cats, birds, rabbits
- ✓ Not just visiting pets pet therapy
- ✓ Not just one shared pet in a facility
- ✓ Home has its own policies and procedures on pets
 - ✓ Pet policy
 - ✓ Pet application form and care plan
 - Resident agreement (terms and conditions)

The Rules

- ✓ No pets in the dining room; on lead
- ✓ Resident must be able to care for the pet inc. cleaning up after them
- ✓ All vaccinations must be up to date and a vet must clear the pet to live in a communal environment
- ✓ Must be a plan in place should the resident no longer be able to care for the pet – no dumping

Impact of Pets in the Home

- ✓ Easier transition for the resident to care
- ✓ Less loneliness, isolation, depression
- Resident maintains independence and mobility
- Other residents benefit from regular pet interactions
- ✓ Pets are not surrendered to shelters





Strengthened Standards

✓ Aligns with Strengthened Standards

- 1.1: Person-centred care
- 1.3: Choice, independence and quality of life
- 3.2: Delivery of care and services
- 7.1: Daily living
- ✓ Higher Everyday Living Fee
 - Opportunity to provide specialist pet services for a fee such as visiting groomers
 - Assistance with caring for the pet when the resident can no longer – keeping them together

Learnings and Tips

- ✓ Resident must own pet prior to moving in
- ✓ Self cleaning litter boxes; Baby gates
- ✓ Cat run; pet friendly garden spaces
- ✓ Don't stress big change for resident and pet
- ✓ Staff can cope they have a heart
- ✓ Ask why not don't be a glass half empty person
- ✓ Use free resources to overcome objections
