8. Presentation of Audit and Annual Financial Statements

A copy of the audited financial accounts for the period 1 July 2024 to 30 June 2025 has been made available to all members in the 2025 Annual Report.

In the auditor's opinion, the financial report presents fairly and accurately the College's financial position as of June 30, 2024, and its financial performance and cash flows for the year. The auditor believes the accounts meet the requirements of the Corporations Act 2001 and the Australian Accounting Standards (including Australian Accounting Interpretations).

- Audited surplus of \$7,649
- Equity of \$8.78m as of 30 June 2025
- The College will see income and surpluses stabilise as education courses stabilises to a more regular level
- Education bookings, and FIPC specifically, remained our strongest revenue stream.
- Interest income was \$361k through term deposits
- Overall income decreased from \$3.5M to \$2.6M
